The above mentioned approval is subject to the following conditions:-

- 1. Principal, Faculty, Teaching and other supporting staff shall be appointed as per norms prescribed by AICTE/University from time to time and the representative of the University shall be associated in the selection process.
- 2. The sanctioned intake shall not be varied without prior approval of the University.
- No other course shall be started without prior approval of the University.
- 4. Adequate funds shall be available with the institute to meet the recurring and non-recurring expenditure of the institute, as prescribed by the university, from time to time.
- 5. The College shall provide the necessary infrastructure, instructional and other facilities as per the AICTE/University norms prescribed from time to time.
- 6. The fees shall be charged as prescribed by the State Govt./University from time to time.
- 7. All admissions shall be made according to regulations/directions of the University.

- 8. The institutions shall not automatically become eligible to receive financial grant/assistance from the Central/State Govt. or any other funding agency.
- 9. The institution shall maintain the record and books of accounts, which shall be audited by Chartered Accountant or any competent authority on annual basis and shall be open for inspection by the university.
- 10. The institution shall furnish requisite returns as prescribed by the University for ensuring maintenance of standards.
- 11. The institution shall be visited by an officer or a committee of the university to inspect and review the progress made by the institution in fulfilling norms and procedures as laid down by the AICTE/University.
- 12. The institution shall not charge any Capitation fee or donation for admission or other higher charges from students or their guardians in any form.
- 13. The institution will have an independent building as per norms of the University with a separate approach.
- 14. This order shall stand cancelled in case the college fails to deposit Affiliation fee (unless specifically exempted) by the due date.
- 15. The affiliation is subject to strict compliance of Anti-Ragging regulations.
